## **Focus On Energy**

WW&LC is one of 106 Wisconsin utilities that partners with Focus on Energy. One of their programs provides free, your choice of energy saving products (see right).

## Time of Day

To help manage peak power usage WW&LC offers a "Time of Day" program that replaces a universal power cost of \$0.097 per kwh with \$0.147 on-peak and \$0.055 off peak charges. This theoretically could cut your electric bill in half though 5-20% reduction is typical depending on how and if usage is changed to preferentially use off-peak power. Savings up to 40% have been documented.

## Residential TOD Rate

Wisconsin Rapids Water Works & Lighting Commission (WWLC) standard residential rate is RG-1. The standard charge of \$0.0979/per kilowatt-hour.

Kilowatt-hours (kWh) are the measure of how much energy is used by a resident over time.

When residential customers select a RG-1 TOD instead of paying \$0.0979 per kWh under the standard RG-1 rate, customers pay \$0.1472/kWh during on-peak times and \$0.0549/kWh during off-peak times. Residential customers can select from one of the following TOD on-peak/off-peak options.

7AM-7PM Monday-Friday is on-peak, all other times (nights and weekends are off-peak)
8AM-8PM Monday-Friday is on-peak, all other times (nights and weekends are off-peak)
9AM-9PM Monday-Friday is on-peak, all other times (nights and weekends are off-peak)

In addition to the above off-peak periods, the following holiday or day designated to be celebrated as such will be billed all as off-peak for the full day: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

RG-1 TOD rates make the most sense for residents that have electric hot water heaters, air conditioners, or other large electric loads that residents are willing to mostly operate during off-peak times. Residential customers who are able and willing to adjust their lifestyle by washing laundry, running the dishwasher, etc., during off peak are also willing to benefit from a TOD rate.

Once a customer begins service on one of the optional RG-1 TOD rates, the customer shall remain on the rate for a minimum of one year. Any customer choosing to be served on a RG-1 TOD rate waives all rights to billing adjustments arising from a claim that the bill for service would be less on another rate than what the customer had selected.

To sign up for a WWLC RG-1 TOD rate, check one of the optional times (listed above) and complete the information (listed below) and return to the WWLC office.

I have read and I agree to the terms and conditions of the Wisconsin Rapids WWLC RG-1 TOD as stated above. I understand any estimated savings provided to me by WWLC are not guaranteed, and my bill may actually rise as a result of my selecting to go on a RG-1 TOD rate.
